# 30 Day Limited Manufacturer's Warranty

Within 30 days of purchase, your Badger Basket product will be repaired (or replaced with same or comparable item, at our option), at no cost to you should you discover any missing part or defect in materials or workmanship under normal and proper usage. Dated sales receipt from an authorized retailer, or other satisfactory proof of purchase, is required. This warranty applies only to the original owner.

Inspect the condition of the item prior to and after assembly. Should you observe any defects, do not use this product and immediately notify Badger Basket to place a warranty claim. Failure to notify Badger Basket within the warranty period and/or attempt to repair the product yourself rather than contacting us shall constitute misuse. Warranty may be invalidated by misuse, improper assembly, failure to honor a warning, failure to supervise, inspect or maintain this item, or intentional or inadvertent damage.

For warranty service, have your assembly manual ready and the product with its packaging nearby. Most replacement parts ship within 1-2 business days Mondays to Thursdays.

This warranty does not cover nor apply to: parts that require replacement under normal use, damage resulting from improper storage, failure to follow the assembly instructions, negligence, misuse, misapplication, products that have been altered by the owner in any way not intended by the manufacturer, normal wear and tear, normal everyday soiling, commercial use, item bought used or secondhand, items returned to the store, items that served as floor models, items that have been altered by an unauthorized 3rd party, failure to perform routine maintenance, or intentional or accidental damage.
